Introduction

Tax system

Explain to students what the tax system is:

A tax system is the way a government collects money from people and businesses to pay for public services like schools, roads and hospitals.

- Inform students that a good tax system should have certain qualities to work well.
 These qualities help the tax system to be fair and effective.
- Provide the qualities of a good tax system:
 - a) Fairness
 - b) Certainty
 - c) Convenience
 - d) Efficiency

Lesson 17 | Tax System

The teacher provides explanations on each of the qualities.

i. Fairness

Fairness means that the tax system should treat everyone justly. People who earn more money or have more wealth should pay more tax, while those who earn less should pay less.

ii. Certainty

Certainty means that taxpayers should know exactly how much tax they have to pay, when to pay it, and how to pay it. There should be no confusion or surprises.

iii. Convenience

Convenience means that paying taxes should be easy and not cause problems for people. The government should make it easy for people to pay their taxes on time and in the best way for them.

iv. Efficiency

Efficiency means that the tax system should collect the right amount of money without wasting time or resources. The government should spend as little as possible on collecting taxes and avoid creating unnecessary burdens for taxpayers.

Consequences for not paying tax

- 1. Begin the lesson by asking students why they think people have to pay tax.
- 2. Briefly explain that taxes help the government pay for important things like schools, hospitals, roads, and the police force.
- 3. Brainstorm on the consequences for not paying tax.
- 4. Give the following consequences for not paying tax.
 - ☐ Less money for schools, hospitals, and roads
 - The government uses tax money to build schools, pay doctors, fix roads and help poor people.
 - If some people do not pay taxes, there is less money to do these things.
 - ☐ Unfair to others
 - · People who pay their taxes end up paying more because others are not paying.
 - ☐ Bad for businesses
 - People who cheat on taxes can sell things more cheaply because they do not pay their fair share.
 - ☐ Makes it harder for the country to grow
 - The government cannot build things like new roads or schools if there is not enough money.
 - This makes it harder for the country to get better and richer in the future.


