B. Qualifications & Experience for Lecturer:

1. By selection from among candidates who possess:

- (i) a Cambridge Higher School Certificate or passes in at least two subjects obtained on one certificate at the General Certificate of Education 'Advanced Level';
- (ii) a Degree in the relevant subject area from a recognised institution;
- (iii) a Master's degree in the relevant subject area from a recognized institution; and
- (iv) at least a Postgraduate Certificate in Education.

Note: For all subject areas marked with an "*", in case you do not have a Post Graduate Certificate in Education, you may still submit your application.

OR

Equivalent qualifications to B 1(i), B 1(ii), B 1(iii) and B 1(iv) above acceptable to the Board.

2. Candidates should -

- (i) reckon at least five years' relevant post degree experience in the field of Education; and
- (ii) be computer literate.

Note II: Part-Time lecturers whose services have already been enlisted should also re-apply.

However, their actual services will be retained until the end of their present contract.

Note III: For scarcity areas (Agriculture, Kreol Morisien, Performing Arts and Geography), consideration may be given to candidates possessing qualifications at B 1(i), B 1(ii), B 1(iv) and B 2(i) above.
